

GLACIER PEAK HIGH SCHOOL - Student Parking Contract -

It is the goal of the Snohomish School District and GPHS to provide as many parking places as possible on our campus. Student parking is a privilege. Any student parking in a GP lot during school hours needs to have both parent and student, read, agree to and sign the following contract:

- Students are not allowed to park in the staff lot, parent/visitor parking lot or Little Cedars Elementary parking lots.
- Use one parking spot and park between the lines. Do not park where there is not a designated parking space.
- Permit must be hung on the vehicle's rearview mirror. If your permit is not in your vehicle, it is **your** responsibility to communicate this with the GPHS campus Security Monitor or main office before 1st period begins.
- Permit is not transferable and **cannot be altered or loaned/sold to another student.**
- Drivers must obey Washington state laws including vehicle insurance requirements.
- Replacing a lost permit will require purchasing a new one, unless circumstances are articulated and approved.

Violations include, but are not limited to, the following:

- Disregarding the above mentioned expectations.
- Students are not permitted to go to (be at or in) a vehicle from the start of 1st period through the end of 6th period (including lunch) without written permission from a staff member.
- Driving & parking carelessly (examples: excessive speed, recklessness, squealing tires, texting).
- School inappropriate items on or in vehicle.
- Leaving campus without signing out (permission is required) at the GP attendance office.

Violation Consequences:

- School Discipline
- You may be issued a fine. Multiple fines may result in loss of campus parking privileges during current or future year.
- Disputes on fines need to occur within 30 days.

Loss of campus parking privileges may result from school disciplinary action. Examples include (but are not limited to) excessive tardiness and unexcused absences.

I am parking my vehicle at my own risk and accept responsibility for loss or damages I may incur. I agree that GPHS is not responsible for theft or vandalism of my vehicle or its contents. I understand that by parking on campus, my vehicle is subject to search. This parking pass may be revoked if the car contains any drugs (or drug delivery devices), alcohol, nicotine, vape, vape accessories or vape related contents; a knife, weapons, or any other violations of school policies. My parents and I have read and agree to the above expectations, rules and regulations.
