



# SNOHOMISH HIGH SCHOOL STUDENT PARKING RULES & REGISTRATION

Welcome to Snohomish High School. It is the goal of the Snohomish School District and SHS to provide as many parking places as possible on our campus. Student parking is a privilege. Please carefully read the following agreement:

- Please respect that students may only park in the student lot, off 7<sup>th</sup> street and in the tennis court lot off of 5<sup>th</sup>.
- Use one parking spot and park between the lines. Do not park where there is not a designated parking space.
- Permit must be hung on the vehicle's rearview mirror. If your permit is not in your vehicle, it is **your** responsibility to communicate this with the SHS campus security or main office before 1<sup>st</sup> period begins.
- Permit is not transferable and cannot be altered or loaned/sold to another student. Vehicle must be insured per Washington State law. Incompliance will result in loss of parking privileges and may include additional school discipline.
- Drivers must obey Washington state laws including vehicle insurance requirements.

Violations include, but are not limited to, the following:

- Disregarding the above mentioned expectations.
- Students are not permitted to go to (be at or in) a vehicle from the start of 1<sup>st</sup> period through the end of 6<sup>th</sup> period.
- Student vehicles are not permitted in the bus loop until all rounds of busses have exited the parking lot
- Driving & parking carelessly (examples: excessive speed, recklessness, squealing tires).
- Loitering (hanging out). Student parking lots close at 3:00 pm weekdays and all day weekends.
- School inappropriate items on or in vehicle.

Violation Consequences:

- Upon receiving a violation, you may be issued a fine and be unable to park on campus for a semester's time or be unable to purchase a parking pass the following year.
- A wheel lock may be placed on a vehicle in violation.
- Student vehicles may be towed at the owner's expense.

**I am parking my vehicle at my own risk and accept responsibility for loss or damages I may incur. I agree that SHS is not responsible for theft or vandalism of my vehicle or its contents. I understand that by parking on campus, my vehicle is subject to search.**
