Dear Kids' Café volunteer:

Thank you for helping us with our 2024 Kids' Café Summer Meal Program. We appreciate your willingness to help area children.

Last summer we served 3,310 breakfasts and 8,681 lunches (for a total of 11,991 meals) to young people from our community. We truly could not have accomplished this without the support and assistance we received from individuals like you. Your help enabled us to feed children who may have otherwise gone without.

Our Kids' Café Summer Meal Program is provided through funding from the U.S. Department of Agriculture. This funding allows us to provide these meals. **Please be aware that there are state and federal guidelines and regulations we must follow to participate in this program.**

What you can expect:

- The program will be held Mondays through Fridays from Thursday, June 20, through Friday, August 30.
- All volunteers work from the Valley View Middle School "headquarters." Volunteers will need to arrive at the Valley View Middle School cafeteria by 8 a.m. and will be needed through about 1:15 p.m. each day. Valley View Middle School is located at 14308 Broadway Avenue SE in Snohomish.
- **Please complete this ASAP - All volunteers (this includes district teachers and staff) must have a current completed volunteer application and criminal history form on file with the district. Online volunteer applications can be found at www.sno.wednet.edu/volunteers or <https://secure.safevisitorsolutions.com/Safe/Volunteer/snohomish/volunteer>. (Note: Volunteers under age 18 do not need to complete the application.) These must be completed and approved before your scheduled volunteer spot.**
- Volunteers should be aged 15 or older (new age requirement for 2024).
- Two to four volunteers are needed each Monday through Friday throughout the summer.
- Volunteers will begin each day helping prep food, serve, restock, monitor, and clean up. Between breakfast and lunch, volunteers will have time for a break and will work with kitchen staff to prepare items for the food truck and the next meal service.
- **Please be sure to bring a book, charged device/phone, homework, or other activity with you should there may be "quiet time" in between breakfast and lunch. Volunteers should remain onsite at Valley View Middle School for the 8 a.m-1:15/1:30 p.m. volunteer shift.**
- There are two opportunities each day for one of the volunteers to ride along on the Kids' Cafe food truck. One volunteer will ride along during breakfast and one during lunch. Due to the high-level interest, we are asking that each volunteer be given at least one opportunity each summer to ride along. Most volunteers will remain at Valley View Middle School to serve, monitor kids, and clean up during the lunch period (though 12:30 p.m.).
- Only volunteers who are 16 and older will be allowed to ride in the Kids' Café food truck.
- A volunteer sign in sheet will be available each day. Please sign in and out every day that you are with us volunteering.

- Because volunteers will be working in a commercial kitchen, please be sure to wear closed-toe, slip-resistant shoes each day. Volunteers may be asked to use kitchen appliances and utensils.
- Long hair should be pulled back and restrained (example - pony tail or hair clip).
- Volunteers do not need to have food handlers' permits.
- Volunteers may need to stand for extended periods of time.
- Volunteers should enjoy working with a diverse group of people and ages.
- Meals will be offered at the following times and locations:
 - Valley View Middle School (14308 Broadway Avenue SE in Snohomish)
 - Breakfast - 8:30-9 a.m.
 - Lunch – Noon -12:30 p.m.
 - Three Rivers Mobile Home Park (13201 Elliott Road in Snohomish)
 - Lunch - 11-11:15 a.m.
 - Circle H Mobile Home Park (6413 123rd Avenue SE in Snohomish)
 - Lunch - 11:45 a.m.-noon
 - Snohomish Library (311 Maple Avenue in Snohomish)
 - Breakfast - 8:30-9 a.m.
 - Lunch – 12:15-1 p.m.
- The program is open to anyone 18 years old and younger. We do not check identification for proof of age or residency. Anyone is welcome. We are not able to give or sell meals to those 19 or older. Please note that if there is a mother with a newborn, infant or toddler child, the mother is allowed to take a meal for that child.
