Dear Volunteer:

Thank you for helping us with our 2021 Kids' Café Summer Meal Program. We appreciate your willingness to help area children.

Last summer, we served 11,860 breakfasts and 13,607 lunches (for a total of 25,467 meals) to young people from our community. We truly could not have accomplished this without the support and assistance we received from volunteers like you. Your help enabled us to feed children who may have otherwise gone without.

Our Kids' Café Summer Meal Program is provided through funding our district receives from the U.S. Department of Agriculture. This funding allows us to provide these meals. **Please be aware that there are state and federal guidelines and regulations we must follow to participate in this program.**

What you can expect:

- The program will be held Mondays through Fridays from Tuesday, June 22 through Friday, August 27.
- All volunteers work from our Valley View Middle School "headquarters." Volunteers will need to arrive at the Valley View Middle School Commons by 8 a.m. and will be needed through about 1 p.m. each day.
- Volunteers should be age 13 or older.
- Three to four volunteers are needed each Monday through Friday throughout the summer.
- Volunteers will be helping with meal prep.
- There are two opportunities each day for one of the volunteers to ride along on the Kids' Cafe food truck. One volunteer will ride along during breakfast and one during lunch. Due to the high-level interest, we are asking that each volunteer be given at least one opportunity each summer to ride along.
- Only volunteers who are 16 and older will be allowed to ride in the Kids' Café food truck.
- A volunteer sign in sheet will be available each day. Please sign in and out every day that you are with us volunteering.
- Because volunteers will be working in a commercial kitchen, please be sure to wear closed-toe, slip-resistant shoes each day. Volunteers may be asked to use kitchen appliances and utensils.
- Volunteers must maintain all health and social distancing guidelines based on current Washington state requirements and as directed by the Snohomish School District and Chartwells.
- **All volunteers must have a current completed volunteer application and criminal history form on file with the district. Online volunteer applications can be found at [www.sno.wednet.edu/volunteers](http://www.sno.wednet.edu/volunteers) or <https://secure.safevisitorsolutions.com/Safe/Volunteer/snohomish/volunteer>. (Note: Volunteers under age 18 do not need to complete the packets.) These must be completed and approved before your scheduled volunteer spot.**

- Long hair should be pulled back and restrained (example - pony tail or hair clip).
- Volunteers do not need to have food handlers' permits.
- Volunteers will be asked to wear masks and frequently wash their hands.
- Volunteers may need to stand for extended periods of time.
- Volunteers should enjoy working with a diverse group of people and ages.
- We will offer meals at the following times and locations:
  - Three Rivers Mobile Home Park - 11:15-11:30 a.m. Lunch (to-go breakfast will also be provided for the next day)
  - Snohomish Boys and Girls Club - 8:30-9 a.m. Breakfast and 11:50 a.m.-12:05 p.m. Lunch
  - Snohomish Aquatic Center - 12:10-12:25 p.m. Lunch (to-go breakfast will also be provided for the next day)
  - Circle H Mobile Home Park - 12:45-1 p.m. Lunch (to-go breakfast will also be provided for the next day)
  - Snohomish Mobile Home Park on Avenue D - 11:20-11:40 a.m. Lunch (to-go breakfast will also be provided for the next day)
  - Snohomish High School - 11:50 a.m.-12:05 p.m. Lunch (to-go breakfast will also be provided for the next day)
  - Valley View Middle School - 12:20-12:35 p.m. Lunch (to-go breakfast will also be provided for the next day)
- The program is open to anyone 18 years old and younger. We do not check identification for proof of age or residency. Anyone is welcome. We are not able to give or sell meals to those 19 or older. Please note that if there is a mother with a newborn, infant or toddler child, the mother is allowed to take a meal for that child.
