

**SNOHOMISH SCHOOL DISTRICT NO. 201
RESOLUTION NO. 14-21**

CERTIFICATION OF 2022 EXCESS PROPERTY TAXES

A RESOLUTION of the Board of Directors of Snohomish School District No. 201, Snohomish County, Washington, certifying to the Snohomish County Council and the Superintendent of NWESD 189, the amount of excess property taxes to be levied in year 2021 and collected in year 2022 for the District's General Fund, Debt Service Fund, and Capital Projects Fund; and providing for related matters.

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF SNOHOMISH SCHOOL DISTRICT NO. 201, SNOHOMISH COUNTY, WASHINGTON, as follows:

Section 1. Findings and Determinations. The Board of Directors (the "Board") of Snohomish School District No. 201, Snohomish County, Washington (the "District") takes note of the following facts and makes the following findings and determinations:

(a) By Resolution No. 11-21, the Board adopted a budget for Fiscal Year 2021-22 (the "2021-22 Budget") that included certified General Fund educational programs and operations excess property taxes in the amount of \$18,765,488 to be levied in 2021 and collected in 2022. The Board has determined that the amount of the District's General Fund educational programs and operations excess tax levy previously certified in the 2021-22 Budget of \$18,765,488 should now be increased to \$19,016,000.

(b) The 2021-22 Budget included certified Debt Service Fund excess property taxes to pay debt service on all of the District's outstanding unlimited tax general obligation bonds in the amount of \$30,000,000 to be levied in 2021 and collected in 2022.

(c) The 2021-22 Budget also included certified Capital Projects Fund excess property taxes in the amount of \$6,305,204 to be levied in 2021 and collected in 2022. The Board has determined that the amount of the District's Capital Projects Fund excess property tax levy previously certified in the District's 2021-22 Budget of \$6,305,204 should be increased to \$6,424,000.

Section 2. Certification of General Fund Excess Property Tax Levy; Assessor Authorization. Pursuant to RCW 84.52.020, the Board certifies to the Snohomish County Council and the Superintendent of NWESD 189, an excess property tax levy in the amount of \$19,016,000 to be levied in calendar year 2021 and collected in calendar year 2022 for the District's General Fund.

Section 3. Certification of Debt Service Fund Excess Property Tax Levy. Pursuant to RCW 84.52.020, the Board certifies to the Snohomish County Council and the Superintendent of NWESD 189, an excess property tax levy in the amount of \$30,000,000 to be levied in calendar year 2021 and collected in calendar year 2022 for the District's Debt Service Fund.

Section 4. Certification of Capital Projects Fund Excess Property Tax Levy. Pursuant to RCW 84.52.020, the Board certifies to the Snohomish County Council and the Superintendent of NWESD 189, an excess property tax levy in the amount of \$6,424,000 to be levied in calendar year 2021 and collected in calendar year 2022 for the District's Capital Projects Fund.

Section 5. General Authorization and Ratification. The Secretary to the Board, the President of the Board, the District's Executive Director of Business Services and other appropriate officers of the District are severally authorized to take all other actions and execute all other documents necessary to effectuate the provisions of this resolution, and all prior actions taken in furtherance of and not inconsistent with the provisions of this resolution are ratified and confirmed in all respects.

Section 6. Effective Date. This resolution takes effect from and after its adoption.
