ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Snohomish School District No. 201 from September 1, 2012 through August 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Aquatic Center contracts/agreements
- Cash receipting at the Aquatic Center
- HD Baker In-Touch receipting system

- Cost allocation
- Student enrollment reporting
- Student transportation reporting
- Surplus property
- System review of asset monitoring

RESULTS

In most areas, the District complied with state laws and regulations and its own policies and procedures.

However, we noted certain matters that we communicated to District management. We appreciate the District's commitment to resolving those matters.

ABOUT THE DISTRICT

Snohomish School District No. 201 provides public school services to approximately 10,000 students in kindergarten through 12th grade. The District's service area covers 165 square miles including the city of Snohomish and neighboring unincorporated portions of Snohomish County. The District operates two high schools, an alternative high school, two middle schools, nine elementary schools, a preschool, a primary care center, a parent partnership program for home-school families and an aquatic center.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 608 certified and 479 classified employees. For the 2012-2013 school year, the District had expenditures of \$148,320,177.

AUDIT HISTORY

We audit the District annually. We issued findings in fiscal years 2007, 2008 and 2009 related to transportation reporting and a finding in fiscal year 2011 related to enrollment reporting for an Alternative Learning Experience program. The 2007, 2008 and 2009 findings have all been resolved. The fiscal year 2011 finding will be reviewed in 2014.
