AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Snohomish School District No. 201 from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll – gross wages, leave cash outs, balances, accruals, and transfers
- Student enrollment reporting
- Accounts payable – electronic funds transfers
- Establishment of local revenue and expenditure accounts
- Use of restricted funds – professional learning
- Financial condition and fiscal sustainability
- Procurement – cooperative purchases and purchasing exemptions
- IT security policies, procedures, practices, and controls protecting user access to financial systems

INFORMATION ABOUT THE DISTRICT

Snohomish School District No. 201 provides public school services to approximately 9,783 students in kindergarten through 12th grade. The District's service area covers 128 square miles including the City of Snohomish and neighboring unincorporated portions of Snohomish County. The District operates two high schools, an alternative high school, two middle schools, ten elementary schools, a preschool, and a parent partnership program for home-school families, and an aquatic center.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 690 certified and 510 classified employees. For the 2018-2019 school year, the District had expenditures of \$174,612,911.
